

A special meeting of the Commissioners Court of Garza County, Texas was held on Tuesday, August 17, 2010 at 11:00 A.M., at the AgriLife Extension office, Post, Texas with the following members present: Lee Norman, Judge; Commissioners: Pct. 1 - Gary McDaniel; Pct. 2- Charles Morris; Pct. 3-Ted Brannon; and Pct. 4-Mike Sanchez.

County officials present were Jim Plummer, Clerk; Mike Munk, Attorney; Judy Bush, Tax Assessor/Collector; and Ruth Ann Young, Treasurer.

Also present was Jerry Benham, candidate for Commissioner Pct. 4.

Judge Norman called the meeting to order at 11:10 A.M.

Order 1: Came on for discussion was a 2010-2011 budget workshop.

The judge led the court through the proposed budget page by page starting with page 67.

The following is the proposed schedule for the budget process:

Take record vote and propose tax rate on 8/23/10.

Publish to set tax rate, 8/27/10.

First public hearing on 9/3/10.

Second public hearing on 9/10/10.

Publish proposed tax rate on 9/17.

Adopt tax rate and budget on 9/24.

Judge Norman informed the court that the City of Post's Municipal Judge will no longer serve as a magistrate judge in rotation with the county Justices of the Peace.

Commissioner Morris suggested that the court decide on the percentage for pay raises. The judge recommends 2% across the board.

AMENDED: All but Commissioner McDaniel concurred.

The rollback tax rate is .36672.

The proposed tax rate is .36: The M & O at .35544 and the debt (on the LAH Fire Station) at .00456.

The original proposed budget has an excess of \$165,112.

The meeting recessed at 12:06 P.M.

The meeting resumed at 1:14 P.M.

The judge resumed reviewing the proposed budget at page 1.

The meeting recessed at 2:03 P.M.

The meeting resumed at 2:14 P.M.

The meeting recessed at 3:06 P.M.

The meeting resumed at 3:14 P.M.

The court finished reviewing the proposed budget on page 27.


The meeting adjourned at 4:03 P.M.


GARY MCDANIEL, COMMISSIONER PCT. 1
