Judge Norman called the commissioners' court portion of the meeting to order at 6:22 P.M. and announced that a quorum of the court was present.


Came up for discussion was a law enforcement contract for the 2009-2010 fiscal year.


Mayor Kim Mills replied that the city council will take the judge's suggestion under advisement.

No action was taken.


The meeting adjourned at 6:25 P.M.
