A special meeting of the Commissioners Court of Garza County, Texas was held on Monday, September 21, 2009 at 9:00 A.M., in the Commissioners Courtroom of the Garza County Courthouse with the following members present: Lee Norman, Judge; Commissioners: Pct. 1-Gary McDaniel; and Pct. 2- Charles Morris; Pct. 3-Ted Brannon; and Pct. 4-Mike Sanchez.

County officials present were: Jim Plummer, Clerk; Judy Bush, Tax Assessor/Collector; and Ruth Ann Young, Treasurer.

Also present was Billie Williams, Secretary to the Judge; and Rosa Latimer-Bell, Post Dispatch.

Judge Norman called the meeting to order at 9:00 A.M.

Order 1: Adopt 2009-2010 Budget

Came on for adoption was the Garza County 2009-2010 fiscal year budget.

A motion to adopt a balanced budget of \$7,430,485.68 for the 2009-2010 fiscal year was made by Commissioner Morris and seconded by Commissioner Sanchez. With the vote being called for and all four commissioners and the judge voting aye, the motion carried and was so ordered.

The meeting recessed at 9:04 A.M.

The meeting resumed at 9:17 A.M.

Order 2: Adopt 2009-2010 Tax Rate

Came on for adoption was the Garza County 2009-2010 fiscal year Tax Rate.

A motion to set the overall tax rate at \$.375 cents per \$100 valuation therefore generating \$2,821,860 in ad valorem tax revenue was made by Commissioner Brannon and seconded by Commissioner Sanchez. With the vote being called for and all four commissioners and the judge voting aye, the motion carried and was so ordered.

*The overall tax rate is the sum of the Maintenance and Operations (M&O) tax rate of \$.36972 per \$100.00 valuation and the Interest and Sinking (I&S) tax rate of \$.00528 per \$100.00.*

The meeting adjourned at 9:21 A.M.





GARY MCDANIEL, COMMISSIONER PCT. 1




CHARLES MORRIS, COMMISSIONER PCT. 2

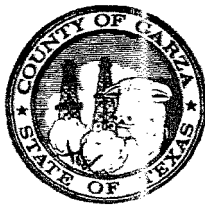
